

43rd Juried Exhibitions Guidelines

Juror: Wassan Al-Khudhairi, Chief Curator at Contemporary Art Museum St. Louis.

Opening Reception: March 22, 2018, 6 pm -8 pm, on view through May 5, 2018

Delivery Dates: All original artworks must be delivered to the Lyndon House Arts Center for consideration. Submission dates are Thursday, January 25, 1:00 – 8:00 pm AND Friday, January 10:00 am – 4:00 pm. (dates and times are FIRM)

Online form: The online submission form will be available beginning January 5, 2018 and will remain available throughout the entry days. Please make every effort to fill out your entry form prior to delivery. **NOTE:** You will not have completed your submission process until you have delivered your artworks and paid your entry fee.

To Enter: A non-refundable fee of \$25 is required. This includes entry for up to three works of art. Checks, cash or cards are accepted. Please write Checks to Lyndon House Arts Foundation.

Entry Information Eligibility: Athens area artists 18 years and older working in the visual arts field. The Athens area includes the following counties: Athens-Clarke County, Oconee, Barrow, Greene, Jackson, Madison, Hall, Banks, Franklin, Hart, Elbert, Wilkes, Morgan, Walton and Oglethorpe.

Artworks: Original artworks in any visual media may be entered. Please no reproductions, no works previously shown at the Lyndon House Arts Center, and no works shown in the Athens area within the last year. Please no multi-piece works, such as diptychs, triptychs or grids. This applies to 2d and 3d works.

Size: Wall works should not exceed 11' in any direction (this includes framing). Sculptural works should not exceed 4' x 8' x 8' and please no more than 100 lbs. Please note that should your work not fall within these requests, they will not be submitted for consideration by the juror.

Awards: This exhibit includes a number of Awards, such as cash, future exhibitions and honorable mentions.

Sales & Reproductions: The exhibiting artist will receive 70% of the sales price. The Lyndon House Arts Foundation, The Lyndon House Arts Center and ACC Leisure Service reserve the right to photograph and reproduce any artwork for promotional purposes. The copyright remains with the artist.

Insurance and Liability: All works submitted for consideration to the 43rd Juried Exhibition will be insured from arrival through February 15, 2018. Works accepted into the 43rd Juried Exhibition will be insured from arrival to May 10, 2018.

Pick up Dates: Please see the calendar included below. (Pick up dates are FIRM).

All works must be finished works of art ready for installation as follows:

1. Works on paper must be mounted and secured in professional frames under glass or plexi-glass and ready for installation. Please no plastic frames or clip style frames.

2. Works on canvas need to have a finished edge whether clean, painted or with wood stripping. Works on canvas boards need to be framed.
3. Hanging devices that are acceptable include d-rings, screw eyes with picture wire securely wrapped. Works under 14" in any direction may use saw tooth hangers.
4. Video works should not exceed 5 minutes in length and should be a mov. or mpg. file. Please submit via Dropbox. Email for further information – beth.sale@athensclarkecounty.com
5. Wall hanging fabric works will need to include a hanging device, such as a casing sewn with a dowel or other mechanism.
6. Photographs mounted on plexi and aluminum are fine as long as the hanging device is incorporated in a professional manner.
7. Extremely fragile works may not be eligible due to the need for special handling.
8. Sculptural work and freestanding pieces must be in one piece and installation ready. Artists may be called to assist with installation.

Friday, February 9, 2018 Notification: The Lyndon House Arts Center will send out all notifications of either acceptance or non-acceptance by email by February 9, 2018. If you require notification via mail, please indicate this on your entry form.

Thursday, February 15, 2018, 1:00 pm – 8:00 pm Pick up works **not included** in the 43rd Juried Exhibition. Please note that works will not be available for pick up prior to this date and time. Artworks not picked up at this date and time will no longer be insured.
